# OWEA General Meeting 1/16/2024

### **Minutes**

Meeting called to order at 7:09pm, Collingwood Presbyterian Church Hall

Correspondence: None

Secretary's Report: Accepted as read, Mac Driscoll 1st, Laure Hammond 2nd. Carried.

**Financial Report:** Kim Howard provided a written report. Summary of 2023 follows:

Net loss \$17k

• Income \$164k (Main drivers: Festival, Annual Fund, Preservation)

Expenses \$181k (Main drivers: festival, Preservation, ARJA)

Know Your Neighbor: Rob Krain & Jen Robertson, Scottwood Garden

The transfer document has been signed. The fees are to be paid via the Garden's funds. There is a need to formalize the relationship with OWEA.

Jen, who has run/been associated with the garden for 20 years, invited neighbors to volunteer or get info about the Garden. New beds are being added, which will bring a total of 20. These plots are available to rent at \$50 (probable increase for 2024) per year via an application process. If you want to just participate but not have your own plot, you are welcome to volunteer with gardening and/or maintenance. There are no chemicals used. Pollinator beds are established. ### **By-Laws**

This was the official 2nd reading of the By-Laws for voting/acceptance. The OWEA by-laws have a good foundation. The revisions are a refinement from a most recent review. Highlights of discussion follows:

- Article V, Section 1a. "Active members are entitled to vote on all matters that come before the OWEA, provided they shall have attended two regular meetings in the six months prior to action to be voted on." It was queried of what is "two regular meetings." At present, it is attending the monthly meeting on the third Tuesday via in person or zoom. Attendance is taken from each. It was asked if committee meetings counted. It was also mentioned that some cannot make the meetings due to other commitments. The Executive Board will discuss at the next Board meeting.
- Also questioned, what defines a member. According to the map supplied with the by-laws, the east side of Collingwood is not OWE. For those who are residents abutting OWE, they are defined as "Invited Members."
- It was noted to remove OWD Security from the list of committees due to its dissolution. A move was made to accept the Revised By-Laws. Mac Driscoll 1st, Finley Gleason 2nd. Motion carried with one abstention.

- Golf carts are a major issue to be reviewed due to 2023 mishaps
- Unscheduled: A neighbor, Karla Butler, stated that they were being harassed by neighbors, and that there were issues with closing their street, Glenwood from Bancroft to Virginia, during the 2023 festival. Ms. Butler stated that she went through the appropriate channels to have the street closed. She also stated that she would not apply for closure for the 2024 festival due to the harassment issues. Ms. Butler continued, voices were raised and they, along with several other neighbors, abruptly left the meeting. Discussion continued. It was observed that since the neighborhood does not have a place for someone to report harassment, it was determined that the Executive Board should look into possibly forming a committee to handle neighborhood problems. A suggestion was made to contact Toledo Human Relations Commission as a liaison. John Howard, Pam Johnson, Laure Hammond, and Justin Bays are interested in a potential "Neighborhood Citizens Board."
